

# Ways to pay your fees

Fees should be paid in full or arrangements made for payment e.g. applying for a student loan by the start of the programme.

## What options are there for arranging payment of my fees?

At MIT, there are a number of funding options that may be available to you or you can apply for a Student Loan.

<p><b>First year fees free</b></p> <p>If you are a first-time tertiary learner, or your first tertiary education was covered by the Targeted Training and Apprenticeship Fund (TTAF), you may be able to get up to \$12,000 of your fees covered for one year's study or two years' training. If you are eligible, we'll organise payment of your fees with the Tertiary Education Commission. For more information, please visit <a href="http://www.manukau.ac.nz/first-year-free">www.manukau.ac.nz/first-year-free</a></p>	<p><b>Maori Pasifika Trades Training Scholarship (MPTT)</b></p> <p>If you are of Maori or Pasifika descent and between the ages of 16 to 40 years, you may qualify for this scholarship. Either visit one of our Ask Me! Student Service Centres to discuss or contact the MPTT office at <a href="mailto:MaoriPasifikaTrades@manukau.ac.nz">MaoriPasifikaTrades@manukau.ac.nz</a></p>
<p><b>Youth Guarantee</b></p> <p>If you are 16 to 24 years old at the start date of your course, you may be entitled to a Youth Guarantee scholarship. A travel allowance is included with this funding. Either visit one of our Ask Me! Centres to discuss or visit our website <a href="http://www.manukau.ac.nz/yg">www.manukau.ac.nz/yg</a></p>	<p><b>Fees paid by a company or other third-party</b></p> <p>If your fees are being paid by a company or other third party, they must confirm that they are paying your fees by providing us with:</p> <ul style="list-style-type: none"> <li>▪ A purchase order number</li> <li>▪ A request for invoice along with the postal address and the name of the company's contact person.</li> </ul> <p>Correspondence should be on company letterhead.</p>
<p><b>Compulsory Student Services Fee (CSSF)</b></p> <p>The Compulsory Student Services Fee (CSSF) levy is additional to your programme or course fees. For more information visit <a href="http://www.manukau.ac.nz/cssf">www.manukau.ac.nz/cssf</a> If you are receiving First year fees free, MPTT or Youth guarantee funding, the CSSF is covered as part of this funding.</p>	<p><b>Student Loan</b></p> <p>You will only need apply for a loan if you are not eligible for other funding options mentioned above. <p><b>Instalment arrangement</b></p> <p>If you are not eligible for a student loan you may be able to pay your fees by instalment.
