FEE WAIVER PROCESS

- MIT will provide a hardship fee waiver form for the Provider’s staff to give to the student to complete, and have approved by MIT (via the Head of Student Experience and Success). The student must supply the approved form to the Provider.
- MIT agrees to meet the cost of the GP or nurse visit only, except as otherwise agreed by MIT in writing (via MIT’s EGM Student Journey or Head of Student Experience and Success).
- For each patient visit covered by this Fee Waiver process, the Provider must record:
 - the date of the visit
 - the MIT student ID number of the patient;
 - if applicable, the MIT staff ID number of the MIT staff member accompanying the student;
 - the category of the patient’s visit (by reference to the service categories outlined in the Schedule); and
 - The costs payable by MIT.
- At the time of the visit, each patient will receive a payment slip from the Provider advising that the cost of the visit will be billed to MIT and that the information collected from the student (as per the above bulletpoints) will be shared with MIT via MIT Student Experience and Success.
- Provider to invoice MIT at the end of the month or quarter for any Fee Waiver visits. Completed MIT Fee Waiver forms must be attached to the invoice.
- MIT will pay the Provider for any accepted Fee Waiver Forms. Where the Fee Waiver form is incorrectly completed or is missing information, payment will be withheld until the Fee Waiver form is completed and any required supporting information presented to MIT.
- No more than two fee waivers are permitted per student – MIT will review this process after six months, and advise the Provider if any amendments are required.
- No more than 100 fee waivers per year are permitted. Any visits in excess of this number must be agreed by MIT in advance in writing (via MIT’s EGM Student Journey or Head of Student Experience and Success).
